ACCOMPLISHMENTS

Bradley Budden's article "On the Intersection of Artificial Intelligence and Copyright Law" (CLLR 47:1) has been cited in the Selected Secondary Sources section of the 2023 Reissue of *Halsbury's Laws of Canada*'s Copyright topic. This is a considerable accomplishment and demonstrates that the author/contributor of the Copyright topic, Sunny Handa, considers CLLR to be authoritative enough to include in the pages of a publication like *Halsbury's*.

In early 2023, I created a poster to encourage law and library school students to submit papers for publication and included information about our article awards. I sent it to 17 academic law librarians and four library school instructors teaching a legal librarianship course during the 2023 winter term. We received a few submissions shortly afterward, including 48:3's article, written by a (now graduated) law student. I'm pleased that we were able to reach students and receive quality submissions as a result.

MOVING FORWARD

Our focus is still on implementing the goals of our strategic plan, including adding a new column, "Perspectives," which I mentioned in my 2023 annual report. Kim Clarke will edit "Perspectives," which will include short (1000–2500 words) articles on topics of interest to CLLR readers. I'm pleased to say that there has been a lot of interest in the column, and Kim has received several submissions already. We originally anticipated that the first column would be in the November 2023 (48:3) issue; however, it has been delayed and will make its debut in the March 2024 (49:1) issue.
